9. any and all actions connected with making securities on property in order to secure customs debts, collecting acknowledgements of receipt and their settlements, collecting cash and payments for SAD documents*,
10. making and signing statements, information, explanations, supplements, declarations and other documents for customs clearance purposes for and on behalf of the Grantor, as stipulated in the customs regulations and other provisions of law /e.g. laws, regulations, etc./ *,
11. signing documents, applications and declarations of the exporter as well and manufacturer, regarding the issued certificates of origin and conforming the status of goods /e.g. T2L, EUR.1 and ATR, CERTIFICATES OF ORIGIN, and other/*,
12. collecting permits and other documents issued by customs authorities*,
13. any and all actions regarding taxes and INTRASTAT declaration for all employees of the FENIX Sp.C. Customs Agency *,
14. making declarations according to the Act on trading in goods, technologies and services of strategic importance to the national security as well as for maintaining international peace and security*,
